










British Columbia Academic Health Science Network



## Update on PREP

Soft launch was September 1, 2018

- o All researchers from partner institutions have access
  - o Training period for non-RISe users where platform use is not required
  - o IT tweaks and adjustments are ongoing
- o UBC researchers see a few differences
  - o New branch-off for Research Involving Indigenous People (in consultation)
  - o System decides on Board of Record (main administrative board)
  - o Cleaner Look

#### Hard launch expected by late October 2018

- o As of this date, all researchers from partner institutions who wish to have a harmonized ethical review must use PREP
- o Harmonized studies will not be reviewed off of PREP
- o Researcher and REBA training is available
  - o Team has travelled to Victoria, Kelowna, around Metro Vancouver, and has additional training rolling out through the next few months
