Brief REBX info

Introduction

REBX is a RISe feature that will connect human research ethics application platforms: RISe (UBC), IRISS (UCalgary), and ARISE (UAlberta) to facilitate the exchange of information and documents.

Websites

<u>UBC</u> website will have current status of study eligibility and which UBC REBs are onboarded.

<u>REBX</u> website for REBX system

Scenarios

Scenario 1 UBC is Board of Record (Lead site)

- UBC RISe application forms will remain the same.
- UBC PI goes through the usual process to obtain REB approval.
- After REB approval, UBC PI can invite UCalgary or UAlberta as participating site.
- UBC documents will be shared with Alberta PI and Alberta REB via REBX.

Scenario 2 UBC is a Participating Site (pSite)

- UAlberta or UCalgary REB approves study then UBC is invited as participating site (pSite).
- UBC PI completes RISe Pages 1-4B or 4C and a truncated site-specific form.
- Alberta site's REB application and documents are shared with UBC via REBX.
- UBC Post-Approval Activity Coversheets remain the same.



Scenario 1 UBC is Lead site

REBX Activation Process

UBC RISe Application forms will remain the same. REBX can only be initiated for REB Approved applications. UBC REB requirements will remain the same. New RISe menu buttons and new tabs will appear when REBX is initiated.





Note, that adding REBX sites is <u>not</u> done via an Amendment. Steps to add pSite, listed below.

How to invite pSite

Login to RISe and Select the approved ethics application. Anyone with online RISe access to the application can add REBX Participating sites. The following shows how to invite a pSite

Accessing pSite info and Application


Login to Rise, find UBC application in [Human Ethics] tab. After clicking on study, you enter Study homepage.

Second method to access pSite house: From Study homepage, there is an **[REBX Sites]** tab. This tab is where UBC team can access each pSite info, Application and PAA.



Blue tabs are your regular UBC file, with [REBX sites] tab as your path to access "pSite's house", which then branches to what is happening at that site (pSite application, PAAs).

UBC lead PI- Post Approval Activities (PAA)

Lead Site PI Responsibility

Submits global + local study amendments

e.g., Changes to study protocol, consent forms, materials.

Submits study annual renewal

*Lead site must ensure all pSite Renewal reports are submitted

Submits global + local site study reportable events/ Request for Acknowledgment:

Eg. Global + local study privacy breaches, *safety updates, Clinical trial- Data Safety Monitoring Board/* Committee (DSMB/C) report.

Submit study closure/ completion

After each pSIte has submitted their closure report to Lead Site REB.

Key points:

- UBC PI is responsible for **global** study amendments, renewals, request for acknowledgements, completions + **local BC** amendments and request for acknowledgements.
- UBC study team will have access to pSite application, amendments, renewals, request for acknowledgements, completions and REB approval certificates.

UBC as lead- Amendments

Lead site is responsible to submit revisions for global Protocol + BC local study documents to lead REB for approval.

If Protocol update necessitates updates to local consent form documents (e.g. additional follow-up visit), ensure to remind **pSite they are still responsible for submitting their local revisions for pSite REB approval.**

UBC as lead- Renewals

UBC PI and primary contact will receive RISe expiry notifications as per usual. pSite teams will receive notifications as per their Ethics platform's usual method. UBC PI to ensure that all pSite Renewal PAAs have been submitted or email pSite PI directly if pSite renewal not submitted in time.

To access pSite renewal info:

See Figure 2 on how to navigate to pSite's house

Click on menu bar l

Download Renewal Progress Report to access enrollment #s.

This action can be run by PI and Study Team after the pSite study is approved by Lead site. Completed renewal form includes pSite data. If not completed, the form is empty.

Once all pSite reports collected, UBC PI submits renewal PAA to UBC REB outlining breakdown enrollment per site in **Clinical PAA Coversheet Box 3.4A/ Behavioural Coversheet box 1.2.3**. UBC REB will review as per delegated review or full board as per UBC REB requirements. After, UBC REB approves the renewal, a joint certificate of approval will be issued.

UBC as lead- Request for Acknowledgment

UBC PI responsible for global + local BC site request for acknowledgements to UBC REB such as Global privacy breaches + local BC privacy breaches. UBC REB has the option to send this info to other pSite REBs.

Note Alberta PAA of this type is named Reportable event.

UBC as lead-Completion


Once all pSites have submitted their pSite Completions forms then UBC study team can submit Study completion. When UBC REB approves, study will be inactivated for all.

If UBC PI needs to provide study sponsor with REB certificate that site has been closed before all the pSites, then this can be done via PAA-Request for Acknowledgement, including important info in Box 1A (Clinical) or just before Question 1A (Behavioural) so that will also copy over to REB Acknowledgement certificate.

Scenario 2: UBC is a Participating Site (pSite)

Process

Initial steps that occur prior to UBC PI seeing application in RISe:



If UBC REB or Lead Site <u>declines</u> the invitation, Lead Site PI/ UBC PI will be notified and REBX will not be initiated at the moment. Another invitation can be sent later if UBC <u>REBX eligibility</u> changes.

If UBC REB **accepts** the invitation then UBC pSite PI will receive an email notification that REBX has been initiated.

UBC PI action items:

- Please login to RISe
- You will find this new application in your [My inbox] tab in Pre-submission state
- Click on new application, if you choose not to participate, click <**Permanently Inactivate>** button in the left side menu.


• If you accept invitation, click < Edit application> and complete application. If you would like your team to complete this, please add team member to Application Page 1, once saved, that individual will have access to application in RISe.

UBC as pSite- RISe Application Form Completion

As per Figure below, UBC PI will complete RISe pages 1- 4B /1-4C as per usual, then a truncated form, concise page 9, then regular RISe pages 10-11. You will also have access to the Alberta approved application and documents.

Local REB process/requirements will remain the same:

- When ready to submit application, it will still require Dept Head approval.
- Operational/Institutional approval are still required when applicable.



Purple look

When UBC is a pSite, RISe application will look visually different. Primary colour will be purple. Study application flow chart and state will be in Purple

Since Lead site approved documents will be downloaded, UBC PI <u>does not need</u> to upload these documents in RISe Page 9 again.

Draft means it is still under REB review. **Final** means approved document and will be listed on Certificate of ethics approval.

UBC Behavioural applications:

You will complete RISe applications Pages 1-4B as per usual then you will be asked to complete the REBX truncated form **Page R-REBX**. This form asks about local details such as local activities, recruitment, consenting and data storage.

UBC Clinical Applications:

You will complete RISe applications Pages 1-4C as per usual, then you will be asked to complete 1 of 4 possible truncated forms: REBX form **Page X** or Page A or Page M or Page C. Which truncated form depends on responses in from Page 4C. **Page X-REBX** asks about local details such as local activities, recruitment, consenting and data/biospecimen storage, regulatory questions.

Please **submit local documents only**, <u>do not</u> submit any duplicate documents that can be found in the **[REBX Lead Site Info]** tab.

If however, there are site-specific documents such as Site Protocol then please add to Box 9.7 for Behavioural application and Box 9.8A for Clinical.

All documents uploaded to Page 9 will be transferred via REBX to lead site.** **Exception-** For Clinical applications: Box 9.9 Reference documents: documents uploaded here will NOT be transferred to Lead site **nor** listed on Certificate of approval. Use this box to upload documents for REB review but you do not want to share with lead site (eg., Budget). Note, there is no need to upload Alberta documents in Box 9.9.

UBC pSite Study expiry date

Study expiry date will be synchronized with Lead site expiry. For the first approval period, this will always be less than the typical 1-year timeframe as lead site is approved first before pSite. After pSite renewal has been approved, then it will be the 1-year approval timeframe. See example below:

UBC pSite Post-Approval Activities (PAA)

UBC PAA forms remain the same.

pSite PI Responsibility

Submits site-specific Amendments

e.g., Changes to local consent form, materials, local study team

Submits pSite Annual Renewal

Submits pSite reportable events /Request for Acknowledgement

e.g, local privacy breaches, local protocol deviations, and local participant complaints, local Serious Adverse Events (SAE).

Submit pSite closure / completion

Once research activities at site are complete and ethics is no longer required.

UBC as pSite- Amendments

pSite PI is still responsible to submit any site-specific amendments, this includes amending RISe application content and UBC documents. For instance, global study Protocols amendments submitted by lead site only cover the submission of the updated Protocol, if Protocol update necessitates updates to local consent form documents (e.g additional follow-up visit), **pSite PI is responsible for submitting local revisions for pSite REB approval.**

UBC as pSite- Renewal

UBC PI will receive email notification to submit a pSite renewal PAA. Complete the RISe PAA-renewal forms, submit in RISe and this will be sent to lead site directly via REBX. Once ready, lead site REB will approve the renewal, issue joint certificate of approval.

UBC as pSite- Request for Acknowledgment

pSite PI is still responsible to submit local events such as local privacy breaches, local participant complaints and local SAEs. Note Alberta PAA uses different terminology, it is named Reportable event.

UBC as pSite-Completion

UBC PI will submit pSite completion PAA to lead site via RISe. Once all pSites have submitted their pSite completion then lead site can submit Study completion. Once lead REB approves, all pSites will show study has been inactivated.
